

CHARACTERIZATION OF THE AGRICULTURE AGENCY IN THE CÁRDENAS MUNICIPALITY

The Municipal Delegation of Agriculture is located on 30th street of our city between Carrillo and 9th streets. The population is served on Tuesdays from 8am and housing cases specifically on Fridays all day.

Procedures carried out by the entity

To request land in usufruct by Decree Law 358, which is the one in force, the personnel will be received in the land department.

For livestock registration procedures, transfers and births, go to the livestock records of:

Camarioca, Santa Marta, Smith Comas and that of the city of Cárdenas on Calle Ayón, corner of Salud.

4 Basic Agricultural Production Units (UBPC): The Strawberry in the Smith Comas village Delirium in Carolina Camarioca in this Popular Council and Humberto Álvarez in the central of the same name. To carry out Processes in the Department of Land:

- Inheritance Process

-bring owner's death certificate

- operative documents of 125

-written request from the promoter-certification of all possible heirs to exist more than one-three witnesses who certify by affidavit that the promoter worked the land 5 years prior to the owner's death

-Letter of the Productive Base to which it was associated with productive results and current state of the farm.

-Application for Land in Usufruct-To attend the Agriculture Delegation with the Identity Card and the specific intention of the productive purpose for which it requests the land in writing.-Bring a 5 pesos stamp

- Extension request-present the Productive Base Guarantee with the results (Plan and Real) of the last 5 years and the current state of the farm.

-Have inspection by the Board of Directors and the Inspection group of the Delegation that verifies the state of the production area and the non-existence of illegalities on the farm.

-Legalization of Tractors-collect in the Agriculture delegation the official model for it-to carry out the technical inspection of the equipment with the technician in mechanization of the productive Base to which it is associated and in the presence of the specialist of the Delegation in Machinery and Irrigation-if it is by transfer, show the latest updated inspection and the file is processed by the outgoing municipality.

- Request for a New Animal Register-show Resolution of Land delivered in usufruct-Make an inspection of the holding area that confirms that it has guaranteed safety, hygiene and feeding conditions for the species in question.

-documentation of transfer of the mass to be acquired with certification from the Department of Animal Health of the municipality or / and outgoing Province

-Avalidation of the Delegation of the conditions of the production area ContactsForest Department 45528520.Livestock Register 45521089.
